### **EXTENSION OF DATE FOR SUBMISSION OF CLAIMS**

A “**PUBLIC ANNOUNCEMENT**” in ‘Form A’ under Regulation 6 of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 was published on the 18<sup>th</sup> October, 2019 in Financial Express (English) and Jansatta (Hindi), New Delhi & NCR and Lucknow editions. The public announcement was given to call upon the creditors of the **M/s Rohtas Projects Limited** to submit their claims, along with proof, on or before **29/10/2019** to the undersigned, being the Interim Resolution Professional of **M/s Rohtas Projects Limited**.

Subsequently, the undersigned had received many requests from the allottees of the projects of Rohtas Projects Limited, for the extension of time for filing of claims, citing various reasons for non-submission of their claims in time, including the stay on the constitution of Committee of Creditors by the Hon’ble National Company Law Appellate Tribunal by order dated 25/10/2019. Considering the above requests, an application was filed by the undersigned before the Hon’ble National Company Law Tribunal, which was pleased to pass an order, dated 12/12/2019 allowing extension of time for filing of the claims till 29/12/2019.

Accordingly, it is hereby informed that the **date for submission of Claims is being extended to 29<sup>th</sup> December 2019**. Following important points may please be noted in this regard:

1. **Only those creditors, who have not submitted their claims as yet, may please submit their claims pursuant to this announcement. PLEASE DO NOT SEND CLAIMS IF ALREADY SUBMITTED.**
